### AGREEMENT

M/s Sattva Global Services Pvt. Ltd, having its registered office at H.No.6-3-1089/G/10&11, First Floor, Opp.Yes Bank,Rajbhavan road,Somajiguda,Hyderabad-500082. Here after refer to as **M/s. Sattva Global Services Pvt. Ltd.** And **Institute of Aeronautical Engineering**, located at sy.no-483 484,488 & 489 Dundigal, Medchal-Malkajgiri District, Telangana-500043. Hereinafter refer as **Institute of Aeronautical Engineering** agrees on this **31-03-2022** follow:

- Sattva Global Services Pvt Ltd** on agrees to provide the services of collection, treatment, and disposal of bio-medical wastes generated by **Institute of Aeronautical Engineering** subject to the terms and conditions specified hereinafter.
- Institute of Aeronautical Engineering** to properly segregate its bio-medical waste and to pack its bio-medical waste in prescribed color-coded HDPE bags.
- Institute of Aeronautical Engineering** will establishes a proper and convenient single collection point at its premises to facilitate the collection of its bio-medical waste by **Sattva Global Services Pvt Ltd.**
- In consideration of the services to be provided by **Sattva Global Services Pvt Ltd** to under this agreement, **Institute of Aeronautical Engineering** agrees to pay **Rs.60000/-**(Sixty Thousand Rupees only) Per Year for Collection Treatment & Disposal of Biomedical waste for each centre/collection point, in the event of guidelines being implemented by TSPCB or CPCB for regularization of charges, the same would be applicable

- e. This service agreement is for a period of **1 Year**, herein refer to as the Term **Institute of Aeronautical Engineering** will not enter into any agreement with any other party for the provision of bio-medical waste management services during the Term.
- f. **Sattva Global Services Pvt Ltd** will collect the bio-medical waste from **Institute of Aeronautical Engineering** premises at such times and for such frequency as mutually agreed by both parties. **Sattva Global Services Pvt Ltd** will not collect any bio-medical waste that is not properly segregated and packed in accordance with Bio-Medical waste (Management & Handling) Rule 2016.
- g. **Sattva Global Services Pvt Ltd** will issue an acknowledgement of the collection of the bio-medical waste (manifest) to **Institute Of Aeronautical Engineering** on the day of collection. This manifest will assist **Institute Of Aeronautical Engineering** in compliance with the requirements from PCB.
- h. **Sattva Global Services Pvt Ltd** will provide training for the staff of **Institute of Aeronautical Engineering** on the proper segregation and packing of bio-medical waste in color-coded HDPE bags, as well as general occupational health and safety aspect of the management and handling of bio-medical waste. After the commencement of this agreement, it is the responsibility of **Institute of Aeronautical Engineering** to ensure compliance by all its staff of the proper bio-medical waste management and handling procedures as prescribed by the PCB.
- i. **Sattva Global Services Pvt Ltd** will maintain their plant in good running condition all the time and ensure continuity of service on all the days without fail.
- j. **Sattva Global Services Pvt Ltd** will supply the consumables like color-coded HDPE Bags, Posters, Bio-Hazard Stickers; Sodium Hypochlorite Solution, PPC Containers and Needle Destroyers at a nominal rate mutually agreed between **Sattva Global Services Pvt Ltd** and **Institute of Aeronautical Engineering** will issue official purchase order to **Sattva Global Services Pvt Ltd** for the supply of above mentioned consumables.
- k. In the event **Sattva Global Services Pvt Ltd** is unable to fulfill its obligation under this agreement due to circumstances beyond its control including but not limited to natural calamities, Nation Wide, State Level strike & hesitations. Above mentioned the situation & conditions considering for not pick up the Bio-Medical waste.
- l. The Advance are will be refundable after discontinuation of the service from **Sattva Global Services Pvt Ltd** all the above points will have legal binding for a minimum period of **1 year Starting** from **01-04-22 to 31-03-23** of this agreement.
