Sub: Shifting of Institutions from Temporary Site to permanent site.

Sir,

As per the records available with AICTE, the institution under reference seems to be operating from a temporary location. In this regard, your attention is invited towards press Notification of AICTE issued on 1st November, 2002 in all leading newspapers in the country, on the decision of AICTE to close down such institutions from the academic year 2003-04.

AICTE is in receipt of several representations from the institutions expressing their difficulties to move into the permanent sites in the midst of academic session. Keeping in view the academic interest of the students, the AICTE has decided, after due consideration, to extend the last date from March 31<sup>st</sup>, 2003 to June 30<sup>th</sup> 2003, or in exceptional cases up to the end of current academic session, and before the commencement of ensuing academic session 2003-2004, for shifting to the permanent sites, provided such institutions submit an affidavit to this effect, to the respective Regional Offices of AICTE, on or before April 30, 2003. A Public Notice was also issued in all leading newspapers on April 12, 2003 in this regard.

In the light of above decision, it is informed that in case, the institution fails to comply with the above stipulations, the extension of approval will not be granted for the academic year 2003-2004 and the institutions will be kept under No Admission Category.




